PARTICIPANT'S AGREEMENT FORM

I, _____, AS A MEMBER OF THE VAWA National Wrestling Team agree to abide by the following rules, regulations and guidelines:

Agree to turn in all finances on time and follow proper procedures.

Agree to abide by all coaching decisions concerning ranking, weight-class and line up changes to benefit the team.

Agree to show up to practices, events, activities and meetings on time.

Agree that the use of, purchase of, transporting of, possession of any alcoholic or drug related substances is grounds for immediate dismissal from the team. An infraction regarding such behavior will result in your parents being contacted and being sent home immediately with any additional costs being borne by your parents.

Agree that the use of any tobacco product is a violation of team rules .

Agree to treat responsibly all property, training camp facilities, dorms, equipment etc., in a mature manner respecting the rules and regulations of the various training and competition sites.

Agree and understand that any knowledge I may have of other team members who are violating team rules, may make me a party to such violations through association and agree to cooperate fully and honestly with the coaching staff in their efforts to investigate violations, to solve disputes and enforce proper discipline.

Agree to conduct myself in a proper manner and avoid all situations that may bring shame or disgrace to myself, my team and my state.

Agree that major and minor violations will be dealt with by the coaching staff on an individual basis and such violations jeopardize my standing on the team and may result in dismissal from competition, activities or being sent home. The head coach has the final authority on all discipline matters. Additionally, any such infraction deemed serious by the coaching staff may result in a one year ban from competing in the next year's State Championship (FS and GR) and qualifying for any of the Virginia National Teams.

Agree that should it be necessary to send me home early my parents will be notified and they will be responsible for arranging transportation home.
