VAWA - TEAM VIRGINIA COACHING STAFF  
AGREEMENT OF UNDERSTANDING

This agreement sets forth the understandings and obligations between VAWA and the undersigned, hereinafter referred to as "Coach," who, in acceptance of this agreement by signature below, agrees to the terms and conditions included herein.

It is understood that in every instance appointment to the Team Virginia Coaching Staff of VAWA, and assignment to any particular event or duty, is a matter of privilege and not a right. Revocation or expiration of such appointment shall give rise to no claim or cause of any nature whatsoever.

Appointment of the Team Virginia Coaching Staff (TVCS) shall be presumed to be for a period of **1 year only**, being as of the date written below. Agreeable extensions of appointment may be made by a duly authorized officer of VAWA, in which instance this agreement shall continue in full force and effect without further witnessing or necessity for written renewal. Coach agrees not to advertise, promote, state, represent, infer or imply that he/she is a member of the TVCS if, in fact, he/she is not a member or their term of appointment has expired, nor shall Coach claim he/she is the Coach, Assistant Coach or other official for any event to which he/she has not been assigned by the Chairman or Coaching Coordinator of VAWA.

**As a VAWA representative and youth chaperone, no coach or individual traveling on behalf of VAWA may consume alcohol or any illegal substance throughout the entire duration of a VAWA-sponsored activity. This includes showing up intoxicated or under the influence of an illegal substance. Individuals having a medical need to consume a psychoactive substance are required to pre-coordinate with VAWA prior to being approved to participate.**

**Violation of this policy will be grounds for immediate removal from staff and revocation of any and all coaching privileges.**

Coach agrees that he/she will abide by and enforce all VAWA and USAW rules and regulations.

Coach understands and agrees that the appearance of impropriety, favoritism, unethical, immoral or unbecoming behavior, as determined by the Team Leader, State Chairman and/or VAWA Board of Directors, in their sole discretion, shall give cause for immediate suspension or dismissal, and such action, if taken, shall be final and without recourse. Being a member of TVCS is a privilege, and the main component is to supervise the athletes and maintain their safety. This safety must be ensured in competition, at training camps and in the dormitories.

Coach agrees that when on assignment as coach of or assistant to Team Virginia, he/she shall be responsible to the Age Group Director, Director of Operations and State Chairman of VAWA.

Coach agrees that when on assignment with TVCS to effectuate and enforce among athletes the known rules regarding athlete eligibility, team membership and social and athletic responsibilities.

Coach agrees to be filmed, photographed, videotaped or otherwise recorded while in the performance of his/her responsibilities as a member of the TVCS and hereby assigns VAWA and USA Wrestling as his/her sole agent in the disposition thereof. Any such recordings, whether visual or auditory taken by or under the direction of VAWA and/or USA Wrestling, shall be the absolute property of VAWA and/or USA Wrestling and no further payment, compensation, consideration, authorization or release shall be necessary for any eventual use or disposition by VAWA and/or USA Wrestling.

Coach has not been convicted of felonies or otherwise unsavory acts within the last ten (10) years, and if coach has been convicted he/she is not eligible to become a member of TVCS.
